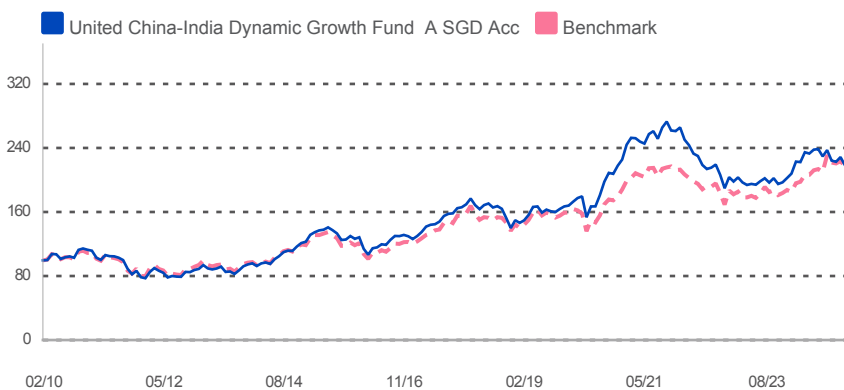


United China-India Dynamic Growth Fund

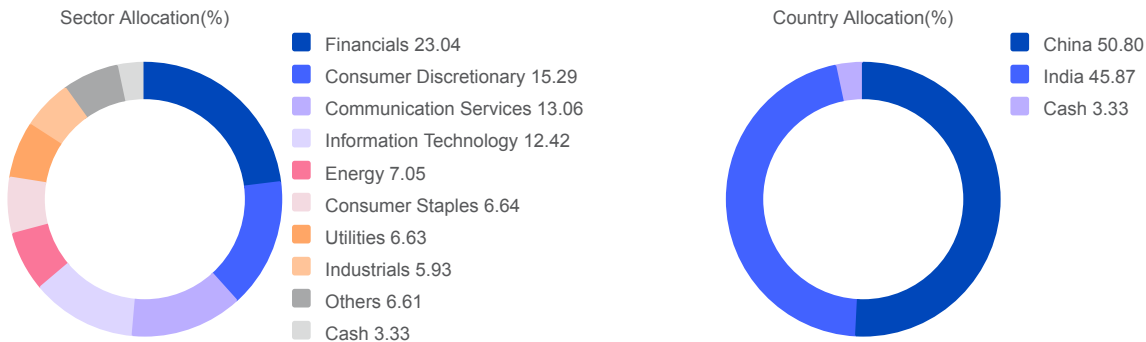
